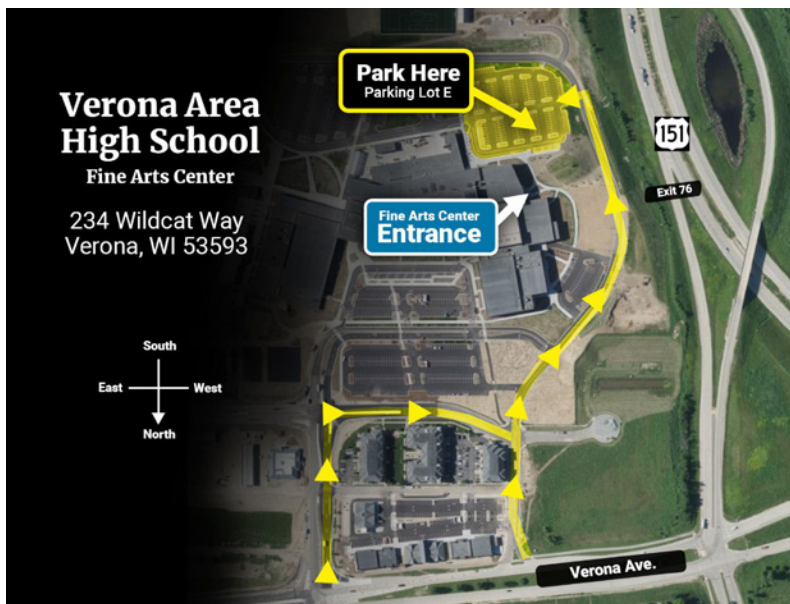

PRAISE BEER! POTOSI AND DICKEYVILLE WISCONSIN

Wednesday, September 18, 2024

We will start the day at the **Dickeyville Grotto & Shrines** which are located on the grounds of Holy Ghost Parish in Dickeyville, WI. They are the works of Father Matthias Wernerus, a German-American priest who served the parish from 1918 until his death in 1931. The main Grotto is an artificial cave created out of stone, mortar, and brightly colored materials and objects collected from all over the world. It was built without the use of blueprints and is supported underground with almost as much material as is visible above ground. In addition to the main Grotto, Father Wernerus constructed several other religious and patriotic shrines throughout the garden area surrounding the Holy Ghost Church. Upon arrival, a representative will step-on the coach and give a short talk about the Dickeyville Grotto & Shrines. Then, you will get off and explore with guides positioned throughout the site to give additional information and answer questions. There is even a small gift shop to visit.

Next, we will head to **Potosi Brewery**. Re-founded on its original site in 2008, the Potosi Brewing Company has brought craft brewing back to Main Street Potosi. Potosi Brewery is where beer is an art form, and their craft is celebrated at the National Brewery

Museum. Their beer is brewed in this town, by its fine people, in small batches with the finest ingredients.



Enjoy a buffet lunch at the Potosi Brewery (Shandy Herb Baked Chicken, Lemon-Basil Baked Cod, Potosi Cheesy Potatoes, Chef's Seasonal Vegetables, Tossed Salad, Eli's Cheesecake, and water, coffee or soda). You will also take a guided tour of the production facility, explore the National Brewery Museum, and then enjoy a free pint in the brewpub and leave with a commemorative pint glass!

Our final stop of the day is a short stop at **Landmark Creamery** which is run by two women both named Anna. Anna Landmark and Anna Thomas Bates plotted a partnership dreaming of creamy sheep's milk and buttery pasture-

grazed cow's milk, carefully handcrafted into beautiful, delicious cheese. Anna Landmark began dreaming about cheese when she started milking her own animals – two feisty goats named Giselle and Celeste and a Milking Shorthorn cow called Freckles. She is now the head cheesemaker for Landmark Creamery. Anna Thomas Bates, a local food writer and grilled cheese champion, has her finger on the pulse of Wisconsin's local food movement, from farmers dedicated to sustainable agriculture to forward-thinking chefs. Everyone leaves with a little gift of cheese!

PROTECT YOURSELF FROM FINANCIAL FRAUD

While we continue to see increased fraud, there are things you can do to help protect yourself. The most critical step in avoiding fraud is to be aware of the types of fraud out there. According to the Federal Trade Commission, fraud has cost U.S. consumers more than \$7 billion just within the first three quarters of 2023. Below are the top five financial frauds that you should look out for in 2024 and how you can avoid them:

- 1. Grandparent Scams** - Scammers call and pretend to be a family member in trouble (they've been arrested or are ill) who needs funds sent immediately to help them. To prevent this:
 - Create a "password" to share with family members to use if they are truly in a dangerous situation.
 - Hang up and call back the family member directly using the phone number you usually reach them at.
- 2. Romance Scams** - You meet a new "love interest" and they gain your trust, tell you that they need money to fly to meet you, and ask you to send them money or purchase items on the scammer's behalf. The scammers tend to ask for payment in gift cards, Venmo, Zelle, PayPal, or cryptocurrency. These types of payments are requested because they are difficult to track. To avoid this fraud:
 - Talk to friends or family about your new "love interest" and pay attention to their concerns.
 - Don't share personal information, usernames, passwords or one-time codes with anyone.
 - If you've just met someone online and they start asking you to send them money, it's a scam!
- 3. Cryptocurrency Scams** - This investment fraud is the costliest type of financial fraud. Scammers use cryptocurrency because there are no legal protections and payments are usually not reversible.
 - If you meet someone online and they want to show you how to invest or send cryptocurrency, it's a scam!
 - A legitimate business or government entity will never ask you for money through email, text, or social media and never demand you buy or pay in cryptocurrency.

4. Employment Scams - Scammers can lure their victims into interviewing for a company that may seem legit. The fake company starts to collect personal information which they may try to use to get your banking information. Other job frauds can promise guaranteed or easy income if you purchase a program or move funds to, or for the scammer. These frauds usually start online, and you generally never meet anyone in person. To avoid this scam:

- Look up the name of the company or the person hiring you. Call the company at a verified phone number. Are other people being scammed by this company or person?
- Never click on an unexpected link even if it seems to come from a company you know.
- Don't ever pay a fee for a job or interview.



- 5. Online Account Tax Scams** - Scammers pretend to be "helpful" third party vendors and offer to help create an IRS online account to pay your taxes for you. The scammers use that information to file fake tax returns to get refunds or use the information to commit other financial fraud or identity theft.
- Do not use a third-party vendor to set up an online account with the IRS.
 - Never store (or send) your financial records or information within or using an email account.

If you are a victim of any type of fraud, end ALL communication immediately and block the phone number. We're here to help too. Reach out to your banker immediately to review your accounts and report the activity to your local law enforcement and the Federal Trade Commission (www.ftc.gov or 1-877-FTC-HELP).
