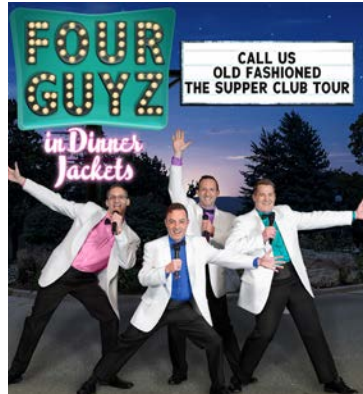

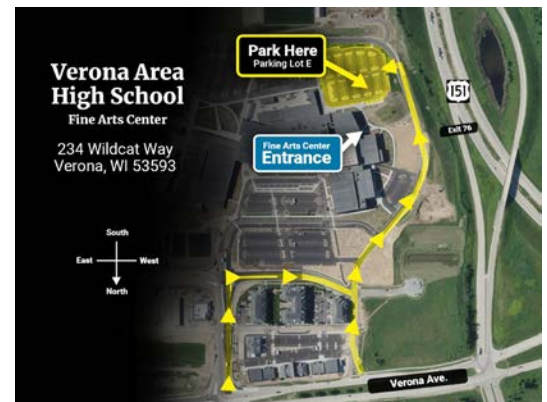

If you'd like to attend, please complete the sign-up form included in this newsletter. We will begin accepting sign-ups immediately and tickets will be assigned based on when signups are

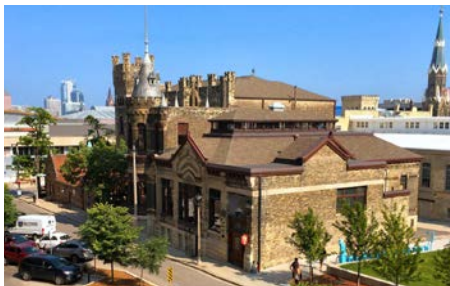
received, on a first come first serve basis. Doors will open 45 minutes prior to each show.

Canadian and New England Fall Foliage Cruise

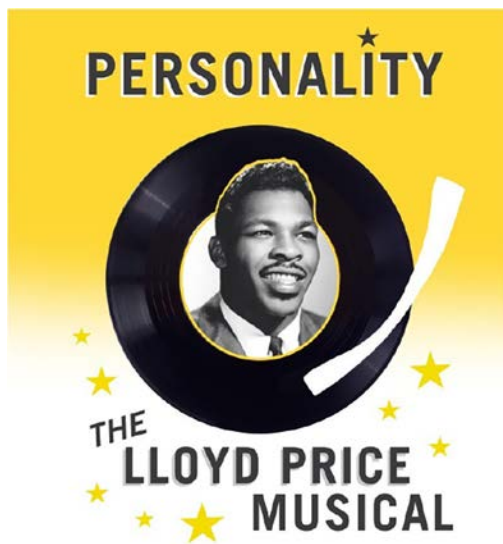
Plan to join us for our Canadian and New England Fall Foliage Cruise Plus Quebec City and Boston! October 8-19, 2024.

PERSONALITY: THE LLOYD PRICE MUSICAL

Studebaker Theatre, Chicago, IL – Wednesday, September 13th, 2023

PERSONALITY! the critically acclaimed new musical celebrates the life, career, and unforgettable songs of trailblazing Rock & Roll Hall of Fame legend, Lloyd Price (1933-2021).



"Personality" features many of Price's classic songs, including "Stagger Lee," "Lawdy Miss Clawdy," and his trademark song, "Personality." The musical's book is by B. Jeffrey Madoff, based on extensive conversations with Price. From humble beginnings in his hometown of Kenner, Louisiana, Lloyd Price overcame incredible obstacles on his way to a revolutionary musical career.

As a young Black recording artist in the segregated Deep South of the pre-Civil Rights Era, Price's success was even more remarkable. Armed with determination and a soulful sound, Price skyrocketed to stardom in 1952 when his single "Lawdy Miss Clawdy" hit No. 1 on the R&B charts, making him the first teenager to sell over a million records and to earn a Gold

Record. Price became a crossover hit, popular with both black and white kids, shattering the "race records" barrier.

However, the path to the Rock & Roll Hall of Fame was a winding one: immediately after the success of his first record, he was drafted to fight in the Korean War in 1953. But Price, a master of reinvention, would find his footing time and again. He became the first black man to open a nightclub below Harlem in New York City, and the first recording artist of any color to create his own record label, generating more hits like "Stagger Lee" and "Personality," and spreading the New Orleans R&B sound throughout the world.

HELP STOP SOCIAL SECURITY-RELATED SCAMS

As you may have heard, March 9th was National Slam the Scam Day to help make people aware of the need to stop the growing problem of Social Security scams. But obviously, protecting yourself against scams should not be limited to one day a year. That's why The Social Security Administration (SSA) and Lake Ridge Bank have teamed up to give you tools to recognize Social Security-related scams and stop scammers from stealing your money and personal information. Since scams can target anyone, be sure to share this scam information with your loved ones and friends to help everyone Slam the Scam!

Recognize the four basic signs of a scam:

1. Scammers **pretend** to be from a familiar organization or agency, like the Social Security Administration. They may email attachments with official-looking logos, seals, signatures, or pictures of employee credentials.
2. Scammers mention a **problem** or a prize. They may say your Social Security number was involved in a crime or ask for personal information to process a benefit increase.
3. Scammers **pressure** you to act immediately. They may threaten you with arrest or legal action.
4. Scammers tell you that you can **pay** to avoid the penalty, or solve the issue, using a gift card, prepaid debit card, cryptocurrency, wire, or money transfer, or by mailing cash. They may also tell you to transfer your money to a "safe" account.
5. Neither Lake Ridge Bank nor the Social Security Administration would ever call you to ask for money or your personal information. If someone does, you can safely assume they are a scammer trying to trick you into giving them your money.

You should always just ignore the scammers (just hang up) and consider reporting fraudulent/criminal behavior. If in doubt, hang up and call the Social Security office or Lake Ridge Bank from a number you know is legitimate. If you do take a call that you feel is a Social Security-related scam, you can report it to the SSA Office of the Inspector General (OIG) by going to: <https://rb.gy/lxi8hg>

You can also visit SSA's web site at www.ssa.gov/scam for more information about current scams and follow SSA OIG on Facebook, Twitter, and LinkedIn to stay up to date on the latest scam tactics they're seeing. As always, if you have a question about scams, or think you may have been a victim of a scammer, please stop by or call any of our 22 locations and speak to a Banking Advisor for assistance.
