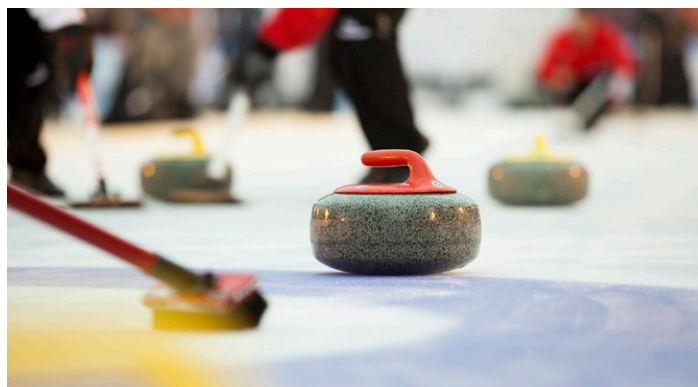
LUNCH AND LEARN: CURLING

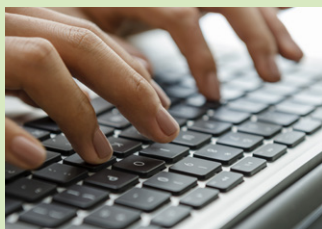
